

## Title Applotment

Castlebin Tithe Applotment books were compiled between 1823 and 1837 in order to determine the amount which occupiers of agricultural holdings over one acre should pay in tithes to the Church of Ireland. The land was measured in Irish acres or plantation acres at the time and this equated to 16198 English acres. The tithe applotment for the townland of Castlebin was undertaken in 1825. It states that the townland of Castlebin was in the parish of Killaan and in the diocese of Clonfert. According to the tithe applotment books Castlebin held Lord Ashtown held 319 acres, 0 roods, and 0 perches which was occupied by 16 tenants. The following is a summary account of the tenants' landholdings, the value of their acres, the amount of composition of the tithe and how this was dispensed among the church hierarchy.

John Cahilan held 17 acres, 0 roods and 29 perches of land and had a total valuation of £1. 11s. and 10d. He paid £0. 5s. 9 ¼ d of a tithe tax.

Michael Callaman held 3 acres, 0 roods and 0 perches of land and had a total valuation of £1. 14s. and 0d. He paid £0. 1s. and ½ d of a tithe tax.

Edmund Cassidy held 14 acres, 1 rood and 0 perches of land and had a total valuation of £5. 16s. and 8 ½ d. He paid £0. 4s. and 5 ½ d of a tithe tax.

John Connor held 13 acres, 1 rood and 30 perches of land and had a total valuation of £7. 6s. and 1 ½ d. He paid £1. 16s. and 3 ¼ d of a tithe tax.

Patt Dolan held 152 acres, 3 roods, and 0 perches of land and had a total valuation of £172. 2s. and 8d. He paid £4. 8s. and 5 ½ d of a tithe tax.

John Feeny held 0 acres, 2 roods and 0 perches of land and had a total valuation of £0. 12s. and 7d. He paid £0. 0s. and 3d of a tithe tax.

Michl Higgins held 4 acres, 1 rood and 0 perches of land and had a total valuation of £6. 1s. and 10 ½ d. He paid £0. 2s. and 6 ¾ d of a tithe tax.

James Hobbins held 9 acres, 2 roods and 0 perches of land and had a total valuation of £13. 7s. and 7d. He paid £0. 5s. and 7 ¼ of a tithe tax.

Pat Hughes held 26 acres, 3 roods, and 26 perches of land and had a total valuation of £47.1s. and 11d. He paid £1. 0s. and 9 ¼d of a tithe tax.

Thomas Mcdermott held 2 acres, 3 roods and 0 perches of land and had a total valuation of £0. 12s. and 6d. He paid £0. 0s. and 8d of a tithe tax.

Pat Naghton held 39 acres, 1 rood, and 15 perches of land and had a total valuation of £63. 18s. and 8d. He paid £1. and 8d of a tithe tax.

Thomas Phillips held 23 acres, 2 roods and 17 perches of land and had a total valuation of £17. 10s. and 0d. He paid £0. 9s. and 2d of a tithe tax.

Patt Raftery held 8 acres, 3 roods and 0 perches of land and had a total valuation of £1. 17s. and 6d. He paid £0. 2s. and 2 ½ of a tithe tax.

Patt Ryan held 7 acres, 0 roods and 0 perches of land and had a total valuation of £1. 4s. and 0d. He paid £0. 2s. and 0d of a tithe tax.

Luke Ryan held 27 acres, 2 roods and 0 perches of land and had a total valuation of £38. 10s. and 0d. He paid £0. 17s and 2 ½ d of a tithe tax.

Pat Trumple held 61 acres, 3 roods and 0 perches of land and had a total valuation of £90. 11s. and 3d. He paid £1.19s. and 5 ¼ d of a tithe tax.
